History of current complaint: Pet presented for acting lethargic, not eating, vomiting, diarrhea that started on Saturday. The pet was obtained from a backyard breeder on Wednesday. No other history, no vaccines.

Physical Examination

General appearance: dull to obtunded

Body condition score: 4/9

Hydration: skin turgor increased with tacky to dry mucous membranes indicating 5-8% dehydration

Eyes: normal eyelids OU; normal conjunctiva OU; normal cornea OU; normal lens OU

Ears: normal vertical canal AU; normal pinna AU

Nose/Thyroid/Trachea: normal planum; no thyroid mass; normal cervical trachea palpation and auscultation

Oral cavity: normal tongue; normal gingiva and teeth; no excessive odor

Cardiovascular: normal heart sounds; normal rhythm; strong, synchronous femoral pulses

Lungs: eupneic; normal bronchovesicular sounds

Lymph nodes: peripheral nodes symmetrical and normally sized

Abdomen: no masses; no organomegaly; fluid filled intestines with abdominal pain noted

Musculoskeletal: no lameness or atrophy observed; full exam not performed

Nervous system: normal mentation; no proprioceptive deficits; full exam not performed

Skin/Haircoat: normal haircoat and skin; no cutaneous masses; no subcutaneous masses

Urogenital/Reproductive: normal external genitalia; no mammary masses

Rectal: Not performed
